Dietitian Nutrition Coaching Certification ECourse Click-Wrap License Agreement

This Click-Wrap License Agreement, (this "**Agreement**"), is a binding contract between Tony Stephan Fitness & Nutrition, LLC, a Michigan Corporation, (hereinafter "TSFN" and "Licensor") and the individual or type of Person intending to download, install or otherwise use the Software, hereinafter referred to as "**Licensee**").

TSFN OFFERS ITS DIETITIAN NUTRITION COACHING CERTIFICATION ECOURSE ("DNCC ECOURSE") FOR LICENSE AND PERSONSAL USE SOLELY ON THE TERMS AND CONDITIONS SET FORTH IN THIS AGREEMENT AND ON THE CONDITION THAT LICENSEE ACCEPTS AND COMPLIES WITH THEM. BY CLICKING THE "ACCEPT" BUTTON BELOW, AND/OR BY DOWNLOADING, INSTALLING OR OTHERWISE USING THE DNCC ECOURSE, LICENSEE (A) ACCEPTS THIS AGREEMENT AND AGREES THAT LICENSEE IS LEGALLY BOUND BY ITS TERMS; AND (B) REPRESENTS AND WARRANTS THAT: (I) IF AN INDIVIDUAL, LICENSEE IS 18 YEARS OF AGE OR OLDER; AND (II) LICENSEE HAS THE RIGHT, POWER AND AUTHORITY TO ENTER INTO THIS AGREEMENT AND BIND LICENSEE TO ITS TERMS. IF LICENSEE DOES NOT AGREE TO THE TERMS OF THIS AGREEMENT, PBN WILL NOT AND DOES NOT LICENSE THE DNCC ECOURSE TO LICENSEE AND LICENSEE MUST NOT DOWNLOAD, INSTALL OR USE THE DNCC ECOURSE OR DOCUMENTATION.

1. <u>Definitions</u>. For purposes of this Agreement, the following terms have the following meanings:

"**Documentation**" means all documentation and other materials related to the DNCC ECOURSE and provided by TSFN, including user manuals, help files and any other instructions, specifications, documents, and materials that describe the functionality, installation, testing, operation, use, maintenance, support, technical features, or requirements of the DNCC ECOURSE.

"**Intellectual Property Rights**" means any and all intellectual property or proprietary rights throughout the world, including all: (i) patent rights (including patent applications and disclosures); (ii) registered and unregistered copyrights (including rights in software, including in source code and object code); (iii) registered and unregistered trademark rights; and (iv) trade secret rights.

"License" has the meaning set forth in Section 2.

"**Licensee**" has the meaning set forth in the preamble. "**TSFN**" has the meaning set forth in the preamble.

"**Person**" means an individual, corporation, partnership, joint venture, limited liability company, governmental authority, unincorporated organization, trust, association or other entity.

"DNCC ECOURSE" means the digital ECourse Program as developed by or for TSFN, and any updates, upgrades, enhancements, releases, improvements, and any other adaptations or modifications made to such DNCC ECOURSE (which may contain, among other things, error corrections or other changes to the functionality, compatibility, capabilities, performance, efficiency, or quality of such DNCC ECOURSE), whether or not owned by TSFN. TSFN is not obligated to update, upgrade, enhance or improve the DNCC ECOURSE.

> "**Term**" has the meaning set forth in <u>Section 9</u>. "**Third Party**" means any Person other than Licensee or TSFN.

2. License Grant and Scope. Subject to and conditioned upon Licensee's strict compliance with all of the terms and conditions set forth in this Agreement, TSFN hereby grants to Licensee a non-exclusive, non-transferable, non-sublicensable limited license (hereinafter, the "License") during the Term to use the DNCC ECOURSE and Documentation, solely as set forth in this Section 2 and subject to all of the conditions and limitations set forth in Section 4 or elsewhere in this Agreement. This License grants Licensee the right to:

(a) use the DNCC ECOURSE only to provide access to Licensee's eligible end users seeking improve their own personal skills and knowledge so that they may effectively coach others in the field of Dietitian Nutrition Coach and be deemed Certified for such purpose. The reproduction, copying, or redistribution of content for purposes is prohibited without the express written permission of TSFN; and

(b) use and run the DNCC ECOURSE as properly installed in accordance with this Agreement and the Documentation, and solely for Licensee's personal use.

3. <u>Use Restrictions</u>. Licensee shall not, directly or indirectly:

(a) use (including make any copies of) the DNCC ECOURSE or Documentation beyond the scope of this License;

(b) permit any other Person (other than its Licensee) to use the DNCC ECOURSE or Documentation;

(c) modify, translate, adapt or otherwise create derivative works or improvements, whether or not patentable, of the DNCC ECOURSE or Documentation or any part thereof;

(d) reverse engineer, disassemble, decompile, decode or otherwise attempt to derive or gain access to the source code of the DNCC ECOURSE or any part thereof;

(e) remove, delete, alter or obscure any trademarks or any copyright, trademark, patent or other Intellectual Property Rights notices from the DNCC ECOURSE or Documentation, including any copy thereof;

(f) except as contemplated by this License, copy the DNCC ECOURSE or

Documentation, in whole or in part;

(g) use the DNCC ECOURSE or Documentation in violation of any foreign, federal, state or local law, regulation or rule; or

(h) use the DNCC ECOURSE or Documentation for purposes of the development of a competing product or service or any other purpose that is to TSFN's commercial disadvantage.

- 4. <u>Responsibility for Use of DNCC ECOURSE</u>. Licensee is responsible and liable for all uses of the DNCC ECOURSE through access thereto provided by Licensee, directly or indirectly. Specifically, and without limiting the generality of the foregoing, Licensee is responsible and liable for all actions and failures to take required actions with respect to the DNCC ECOURSE by Licensee or by any other Person to whom Licensee may provide access to or use of the DNCC ECOURSE, whether such access or use is permitted by or in violation of this Agreement.
- 5. <u>Maintenance and Support</u>. This License does not entitle Licensee to any maintenance or support services with respect to the DNCC ECOURSE.

6. <u>Collection and Use of Information</u>.

Licensee acknowledges that DNCC ECOURSE may, directly or indirectly through the services of Third Parties, collect, use and store information regarding Licensee's use of the DNCC ECOURSE to improve the performance of, or develop updates to, the DNCC ECOURSE.

7. <u>Intellectual Property Rights</u>. Licensee acknowledges and agrees that the DNCC ECOURSE and Documentation are provided under license, and not sold, to Licensee. Licensee does not acquire any ownership interest in the DNCC ECOURSE

or Documentation under this Agreement, or any other rights thereto other than to use the same in accordance with the License, and subject to all of the terms, conditions and restrictions under this Agreement. TSFN reserves and shall retain their entire right, title and interest in and to the DNCC ECOURSE and Documentation and all Intellectual Property Rights arising out of or relating to the DNCC ECOURSE and Documentation, except as expressly granted to the Licensee in this Agreement. Licensee shall safeguard all DNCC ECOURSE and Documentation (including all copies thereof) from infringement, misappropriation, theft, misuse or unauthorized access. Licensee shall promptly notify TSFN if Licensee becomes aware of any infringement of TSFN's Intellectual Property Rights in the DNCC ECOURSE or Documentation and fully cooperate with TSFN in any legal action taken by TSFN to enforce its Intellectual Property Rights.

8. <u>Term and Termination</u>.

(a) This Agreement and the License shall remain in effect unless terminated as set forth herein (the "**Term**").

(b) Licensee may terminate this Agreement by ceasing to use and destroying all copies of the DNCC ECOURSE and Documentation.

(c) Either party may, upon written notice to the other party, terminate this Agreement for material breach, provided that such material breach is not cured within thirty (30) days following receipt of such notice.

(d) Upon expiration or earlier termination of this Agreement, the License shall also terminate, and Licensee shall cease using and destroy all copies of the DNCC ECOURSE and Documentation.

(e) Notwithstanding any expiration or termination of this Agreement, any provisions of this Agreement which by their terms are intended to survive expiration or termination of this Agreement shall so survive and continue in full force and effect.

9. <u>Warranty Disclaimer</u>. THE DNCC ECOURSE AND DOCUMENTATION ARE PROVIDED TO LICENSEE "AS IS" AND WITH ALL FAULTS AND DEFECTS WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, TSFN, ON ITS OWN BEHALF AND ON BEHALF OF ITS AFFILIATES AND ITS AND THEIR RESPECTIVE LICENSORS AND SERVICE PROVIDERS, EXPRESSLY DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, WITH RESPECT TO THE DNCC ECOURSE AND DOCUMENTATION, INCLUDING ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT, AND WARRANTIES THAT MAY ARISE OUT OF COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OR TRADE PRACTICE. TSFN PROVIDES NO WARRANTY OR UNDERTAKING, AND MAKES NO REPRESENTATION OF ANY KIND THAT THE DNCC ECOURSE WILL MEET THE LICENSEE'S REQUIREMENTS, ACHIEVE ANY INTENDED RESULTS, BE COMPATIBLE OR WORK WITH ANY OTHER SOFTWARE, APPLICATIONS, SYSTEMS OR SERVICES, OPERATE WITHOUT INTERRUPTION, MEET ANY PERFORMANCE OR RELIABILITY STANDARDS OR BE ERROR FREE OR THAT ANY ERRORS OR DEFECTS CAN OR WILL BE CORRECTED.

10. <u>Limitation of Liability</u>. TO THE FULLEST EXTENT PERMITTED UNDER APPLICABLE LAW:

IN NO EVENT WILL TSFN OR ITS AFFILIATES, OR ANY OF12. (a) ITS OR THEIR RESPECTIVE LICENSORS OR SERVICE PROVIDERS, BE LIABLE TO THE LICENSEE OR ANY THIRD PARTY FOR ANY USE, INTERRUPTION, DELAY OR INABILITY TO USE THE DNCC ECOURSE, LOST REVENUES OR PROFITS, DELAYS, INTERRUPTION OR LOSS OF SERVICES, BUSINESS OR GOODWILL, LOSS OR CORRUPTION OF DATA, LOSS RESULTING FROM SYSTEM OR SYSTEM SERVICE FAILURE, MALFUNCTION OR SHUTDOWN, FAILURE TO ACCURATELY TRANSFER, READ OR TRANSMIT INFORMATION, FAILURE TO UPDATE OR PROVIDE CORRECT INFORMATION, SYSTEM INCOMPATIBILITY OR PROVISION OF INCORRECT COMPATIBILITY INFORMATION OR BREACHES IN SYSTEM SECURITY, OR FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, EXEMPLARY, SPECIAL OR PUNITIVE DAMAGES, WHETHER ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT, BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT PBN WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

(b) IN NO EVENT WILL TSFN'S AND ITS AFFILIATES', INCLUDING ANY OF ITS OR THEIR RESPECTIVE LICENSORS' AND SERVICE PROVIDERS', COLLECTIVE AGGREGATE LIABILITY ARISING OUT OF OR RELATED TO THIS AGREEMENT, WHETHER ARISING OUT OF OR RELATED TO BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, EXCEED THE PRICE PAID BY LICENSEE TO TSFN FOR THIS LICENSE.

(c) THE LIMITATIONS SET FORTH IN THIS <u>SECTION 10</u> SHALL APPLY EVEN IF THE LICENSEE'S REMEDIES UNDER THIS AGREEMENT FAIL THEIR ESSENTIAL PURPOSE.

11. <u>Confidentiality</u>. Each party agrees to use commercially reasonable efforts to maintain the confidentiality of any confidential information of the other party that it obtains pursuant to this Agreement consistent with the efforts such party uses to protect its own confidential and trade secret information of like importance, and shall take all reasonable steps to ensure that such confidential information is not disclosed or distributed by its employees or agents to third parties not subject in writing to an agreement to protect such confidential information. Each party agrees that the DNCC ECOURSE and Documentation shall be deemed confidential information of TSFN.

12. <u>No Legal Advice</u>. The DNCC ECOURSE may provide information concerning potential legal issues, but it is not a substitute for legal advice from qualified counsel. At no time does TSFN review information for legal sufficiency, draw legal conclusions, provide legal advice, opinions or recommendations about anyone's legal rights, remedies, defenses, options, selection of forms, or strategies. Use of the DNCC ECOURSE does not create any fiduciary relationship between Licensee and TSFN. The accuracy of the DNCC ECOURSE is neither warranted nor guaranteed and Licensee uses the DNCC ECOURSE at its own risk. Documents created using the DNCC ECOURSE may require consultation with an attorney prior to execution or filing. Use of the DNCC ECOURSE for the benefit of another if Licensee is not licensed to practice law may subject Licensee to civil and criminal penalties for the unauthorized practice of law.

13. <u>Miscellaneous</u>.

(a) This Agreement shall be governed by and construed in accordance with the internal laws of the State of Michigan without giving effect to any choice or conflict of law provision or rule (whether of the State of Michigan or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the State of Michigan. Any legal suit, action or proceeding arising out of or related to this Agreement or the matters contemplated hereunder shall be instituted exclusively in the courts within the State of Michigan, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action or proceeding and waives any objection based on improper venue or forum non conveniens.

(b) The relationship between Licensee and TSFN established by this Agreement is that of independent contractors. No joint venture or partnership is established by this Agreement. Neither party is the agent, broker, partner, employee, or legal representative of the other for any purpose.

(c) All notices, requests, consents, claims, demands, waivers and other communications hereunder shall be in writing and shall be deemed to have been given: (a) when delivered by hand (with written confirmation of receipt); (b) when received by the addressee if sent by a nationally recognized overnight courier (receipt requested); (c) on the date sent by facsimile or e-mail of a PDF document if sent during normal business hours of the recipient, and on the next business day if sent after normal business hours of the recipient; or (d) on the third day after the date mailed, by certified or registered mail, return receipt requested, postage prepaid. Such communications must be sent to the respective parties at the addresses as may be designated by a party from time to time.

(d) This Agreement, together with all schedules attached hereto constitutes the sole and entire agreement between Licensee and TSFN with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations and warranties, both written and oral, with respect to such subject matter.

(e) Licensee shall not assign or otherwise transfer any of its rights, or delegate or otherwise transfer any of its obligations or performance, under this Agreement, in each case whether voluntarily, involuntarily, by operation of law or otherwise, without TSFN's prior written consent, which consent TSFN may give or withhold in its sole discretion. For purposes of the preceding sentence, and without limiting its generality, any merger, consolidation or reorganization involving Licensee will be deemed to be a transfer of rights, obligations or performance under this Agreement for which TSFN's prior written consent is required. No delegation or other transfer will relieve Licensee of any of its obligations or performance under this Agreement. Any purported assignment, delegation or transfer in violation of this Section is void. TSFN may freely assign or otherwise transfer all or any of its rights, or delegate or otherwise transfer all or any of its obligations or performance, under this Agreement without Licensee's consent. This Agreement is binding upon and inures to the benefit of the parties hereto and their respective permitted successors and assigns.

(f) This Agreement is for the sole benefit of the parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer on any other Person any legal or equitable right, benefit or remedy of any nature whatsoever under or by reason of this Agreement. (g) This Agreement may only be amended, modified or supplemented by an agreement in writing signed by each party hereto. No waiver by any party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the party so waiving. Except as otherwise set forth in this Agreement, no failure to exercise, or delay in exercising, any right, remedy, power or privilege arising from this Agreement shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.

(h) If any term or provision of this Agreement is invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction.

(i) For purposes of this Agreement, (a) the words "include," "includes" and "including" shall be deemed to be followed by the words "without limitation"; (b) the word "or" is not exclusive; and (c) the words "herein," "hereof," "hereby," "hereto" and "hereunder" refer to this Agreement as a whole. This Agreement shall be construed without regard to any presumption or rule requiring construction or interpretation against the party drafting an instrument or causing any instrument to be drafted. All schedules referred to herein shall be construed with, and as an integral part of, this Agreement to the same extent as if they were set forth verbatim herein.

(j) The headings in this Agreement are for reference only and shall not affect the interpretation of this Agreement.
